### 1. General description

The 74CBTLV3861 is a 10-bit bus switch with one output enable  $(\overline{OE})$  input. When  $\overline{OE}$  is LOW, the switch is closed and port A is connected to the B port. When  $\overline{OE}$  is HIGH, the switch is disabled.

To ensure the high-impedance OFF-state during power-up or power-down,  $\overline{\text{OE}}$  should be tied to the  $V_{CC}$  through a pull-up resistor. The minimum value of the resistor is determined by the current-sinking capability of the driver.

Schmitt trigger action at control input makes the circuit tolerant to slower input rise and fall times across the entire  $V_{CC}$  range from 2.3 V to 3.6 V.

This device is fully specified for partial power-down applications using  $I_{OFF}$ . The  $I_{OFF}$  circuitry disables the output, preventing the damaging backflow current through the device when it is powered down.












Fig. 10. ON resistance as a function of input voltage;  $V_{CC} = 2.5 \text{ V}; I_{SW} = 64 \text{ mA}$









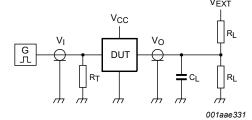
Fig. 15. Enable and disable times




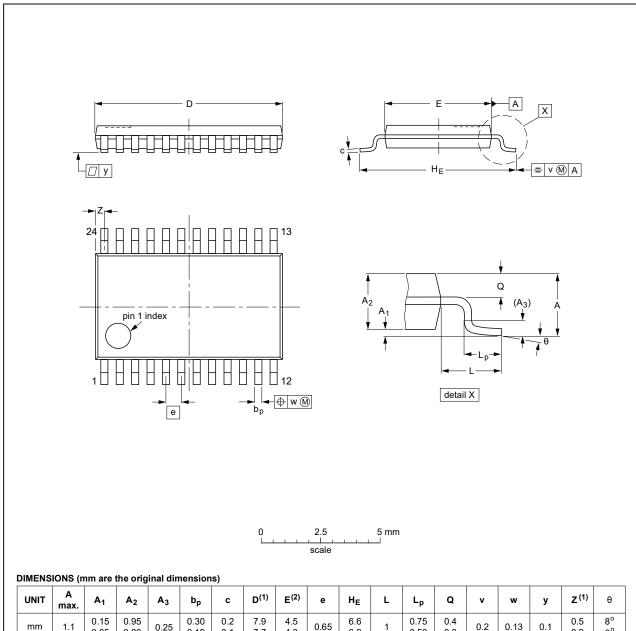
Fig. 17. Test circuit for measuring the frequency response when channel is in ON-state




Fig. 19. Package outline SOT815-1 (DHVQFN24)
