## 1. General description

The 74AHC1GU04 is a single unbuffered inverter. Inputs are overvoltage tolerant. This feature allows the use of these devices as translators in mixed voltage environments.

#### 2. Features

- Wide supply voltage range from 2.0 to 5.5 V
- Overvoltage tolerant inputs to 5.5 V
- High noise immunity
- CMOS low power dissipation
- Latch-up performance exceeds 100 mA per JESD 78 Class II Level A
- Symmetrical output impedance

  - HBM JESD22-A114E: exceeds 2000 V
  - MM JESD22-A115-A: exceeds 200 V
  - CDM JESD22-C101C: exceeds 1000 V
- Specified from -40 °C to +125 °C



#### 11.1. Waveform and test circuit













Fig. 15. Package outline SOT753 (SC-74A)
