1. General description

The 74LV04 is a hex inverter. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess $V_{\rm CC}$.









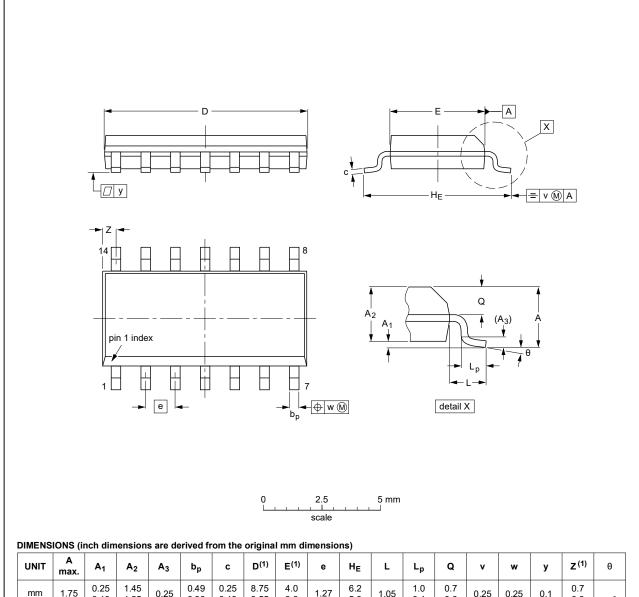






Fig. 10. Package outline SOT762-1 (DHVQFN14)
