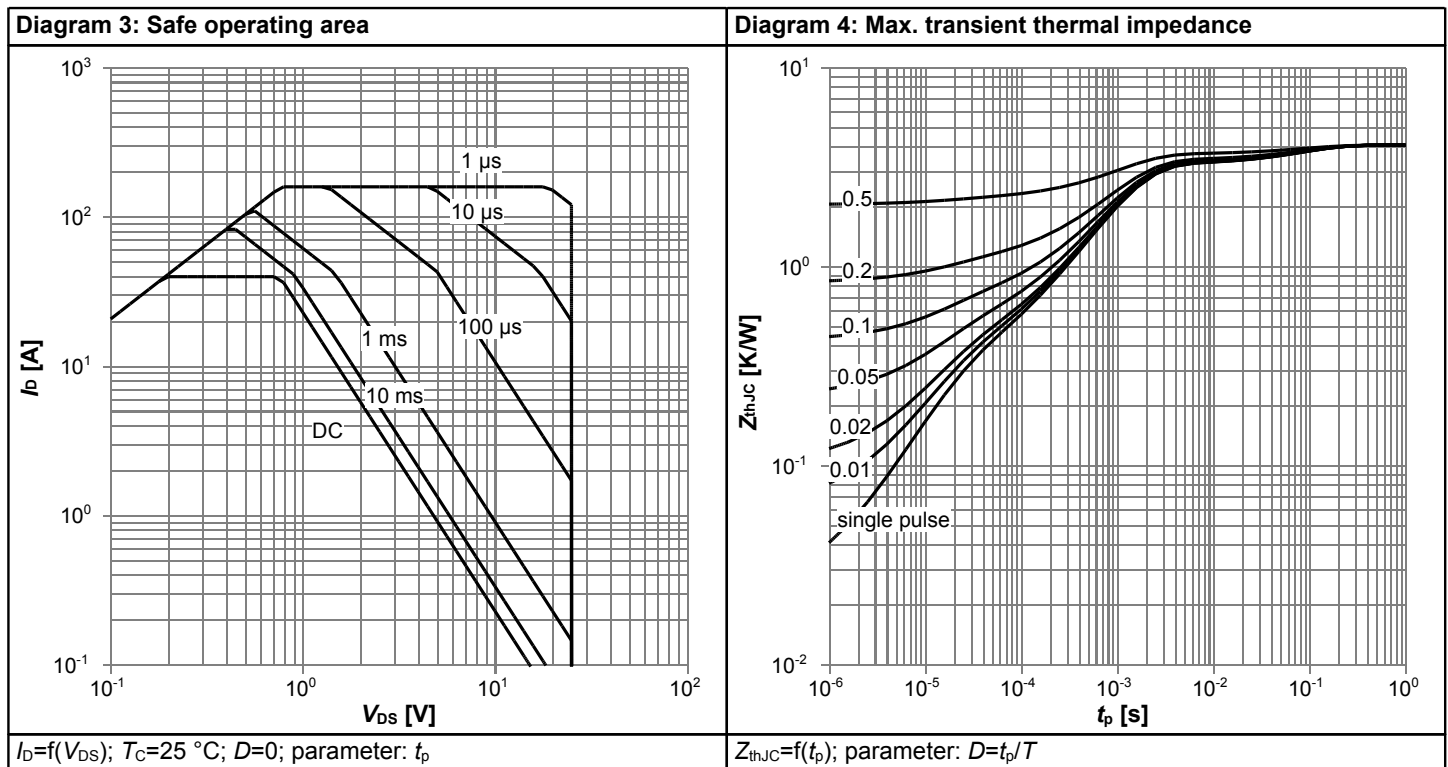
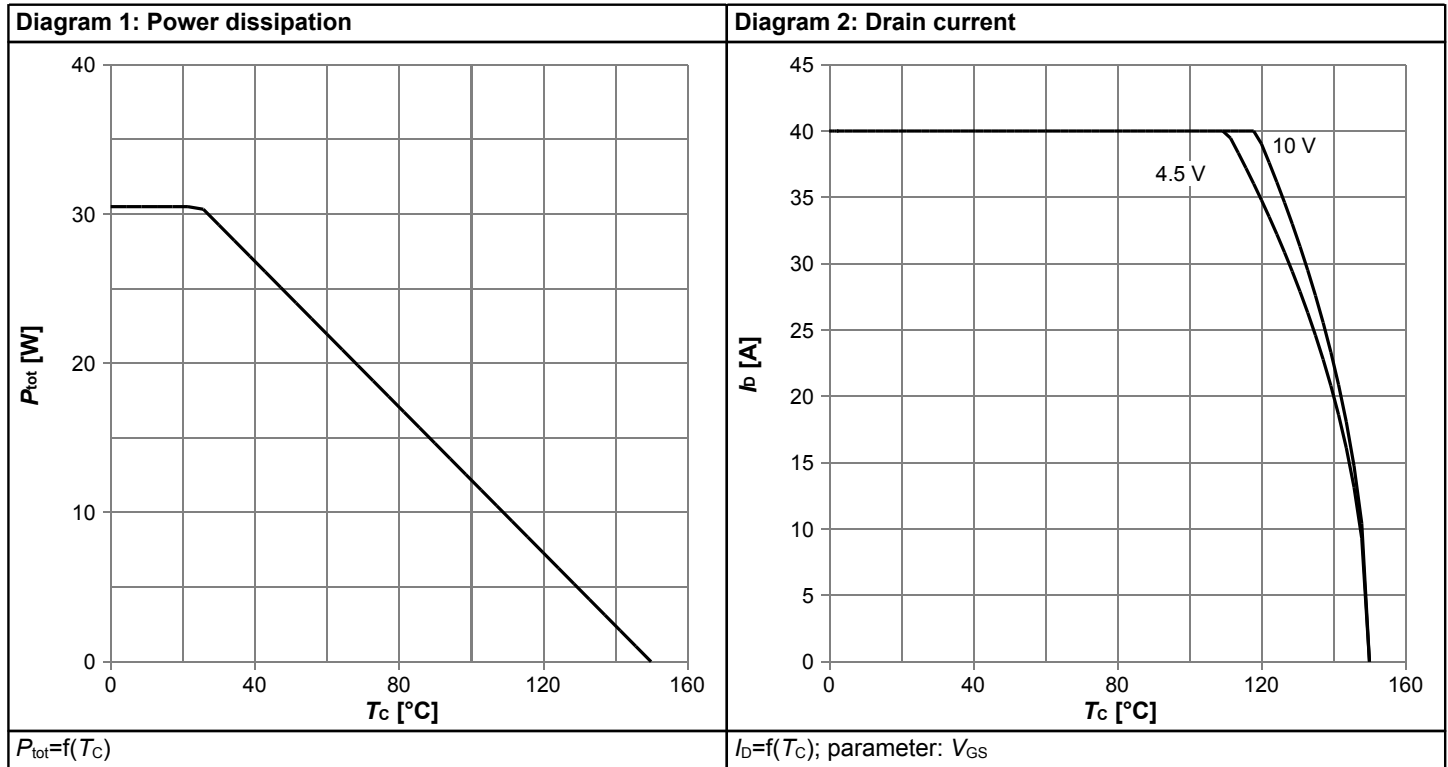
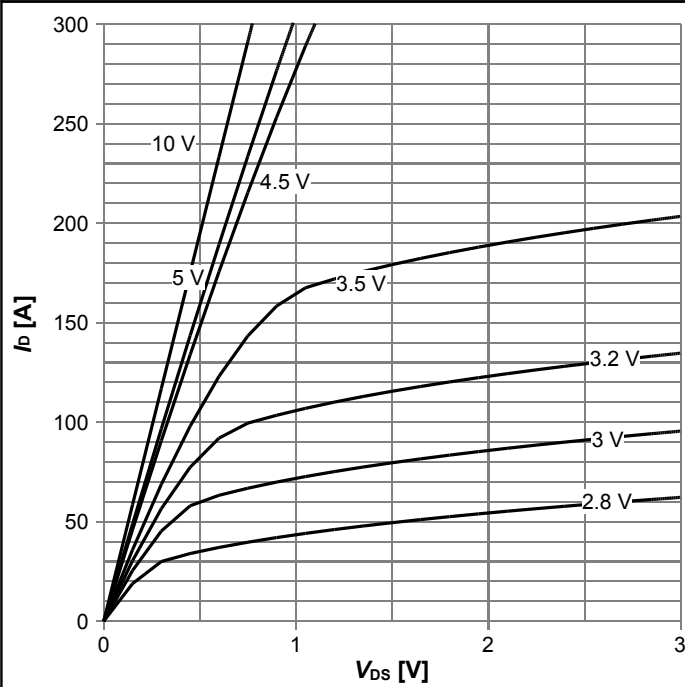
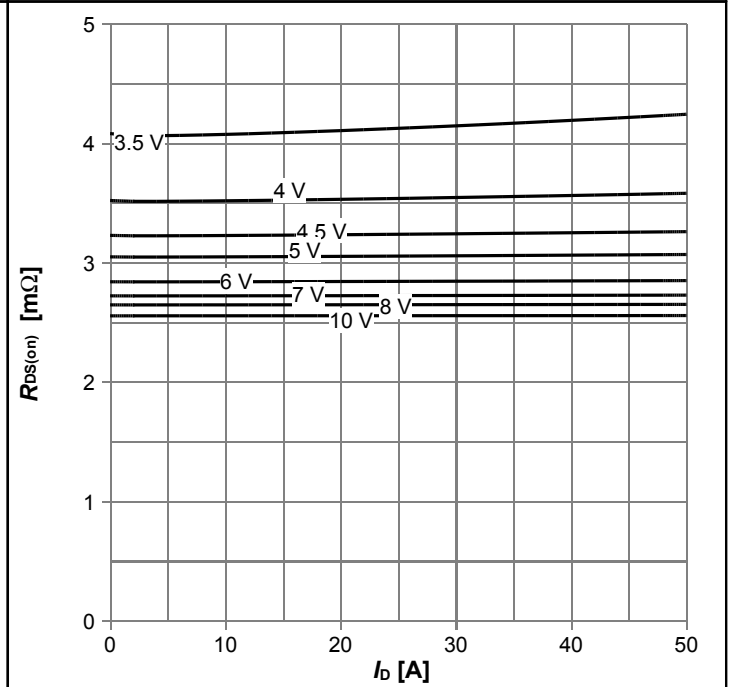


Diagram 5: Typ. output characteristics



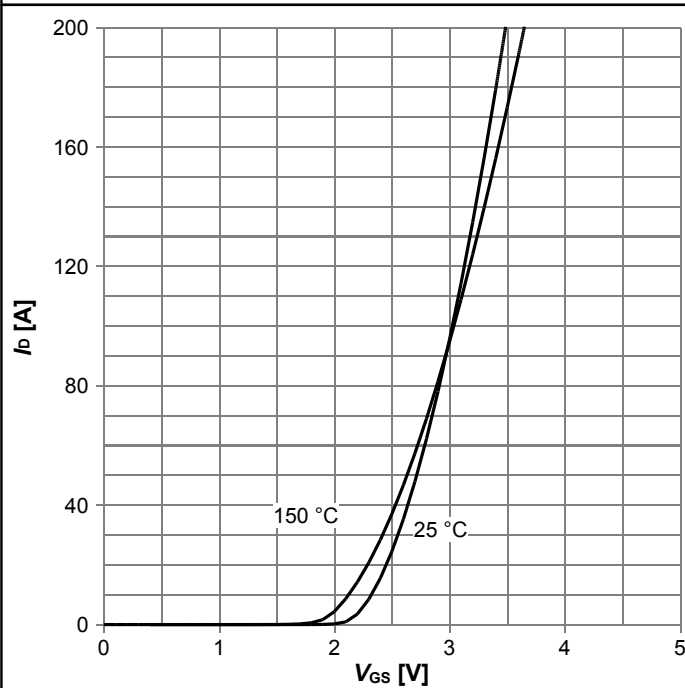
$I_D = f(V_{DS}); T_j = 25\text{ °C}; \text{parameter: } V_{GS}$

Diagram 6: Typ. drain-source on resistance



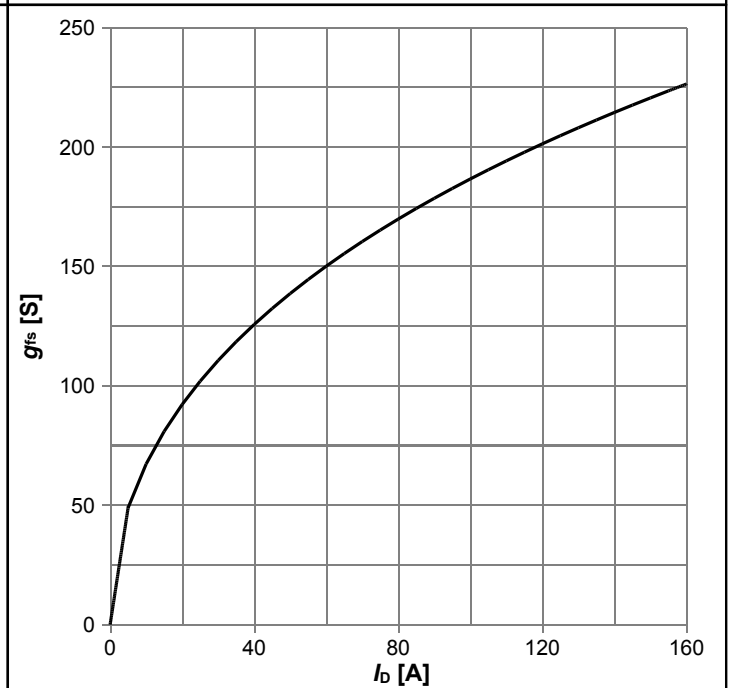
$R_{DS(on)} = f(I_D); T_j = 25\text{ °C}; \text{parameter: } V_{GS}$

$I_D = f(V_{GS}); |V_{DS}| > 2|I_D|R_{DS(on)max}; \text{parameter: } T_j$

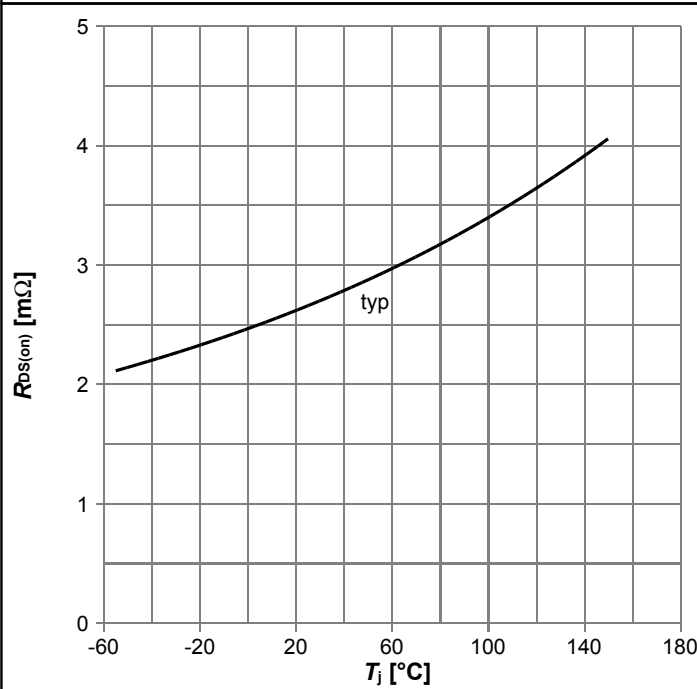
Diagram 8: Typ. forward transconductance



$g_{fs} = f(I_D); T_j = 25\text{ °C}$

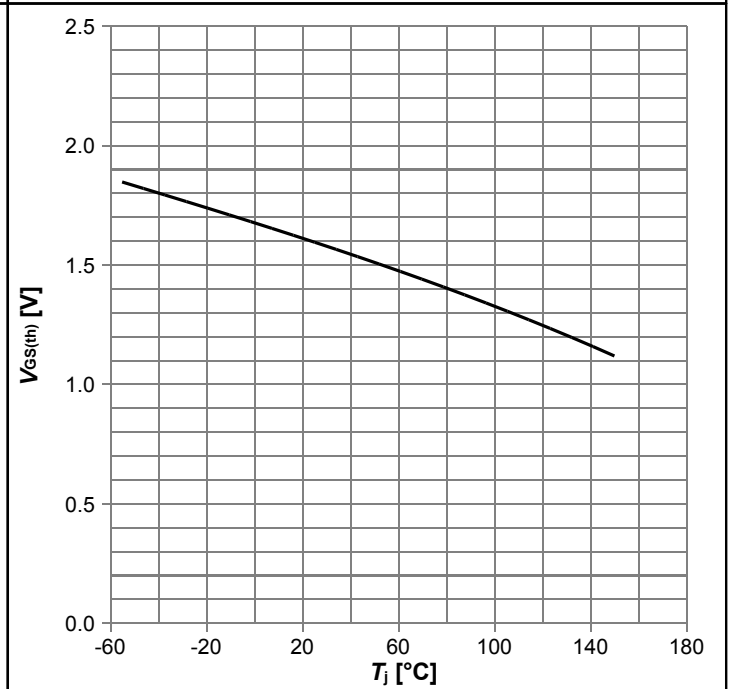


Diagram 9: Drain-source on-state resistance



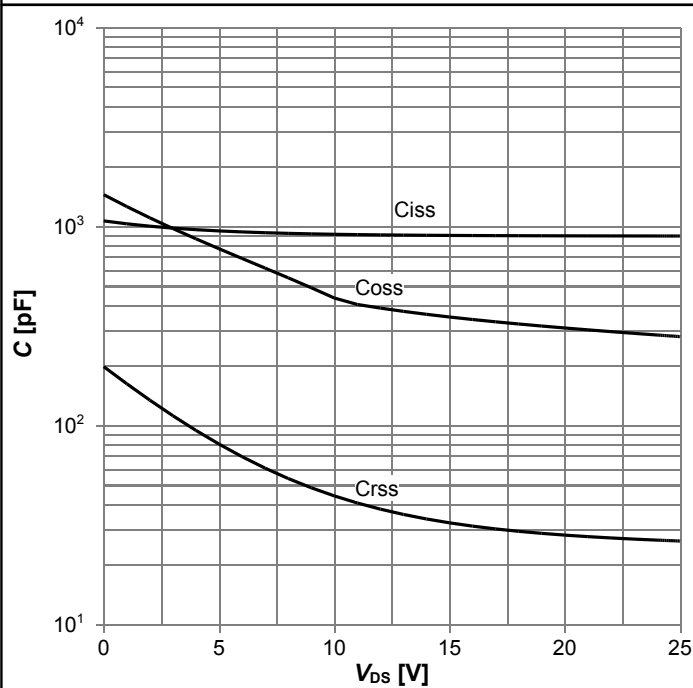

Diagram 10: Typ. gate threshold voltage



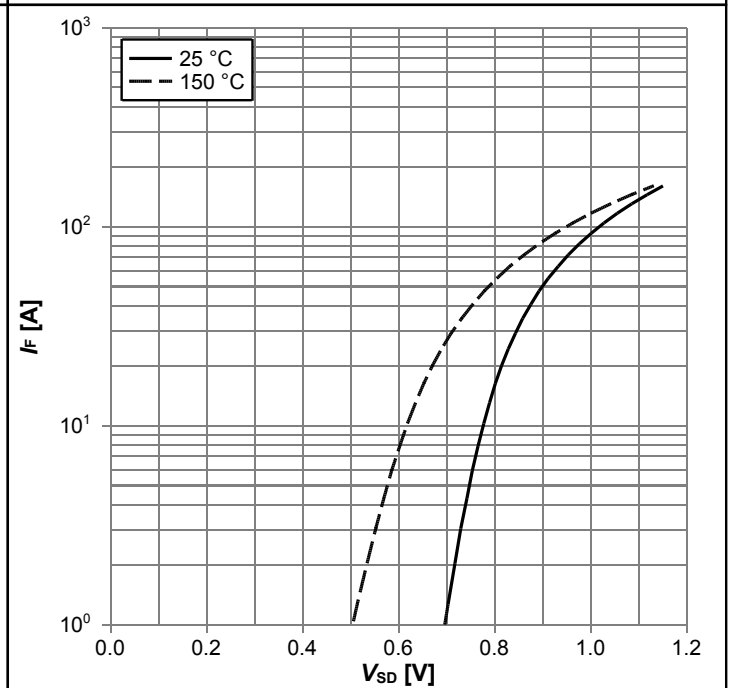

Diagram 11: Typ. capacitances



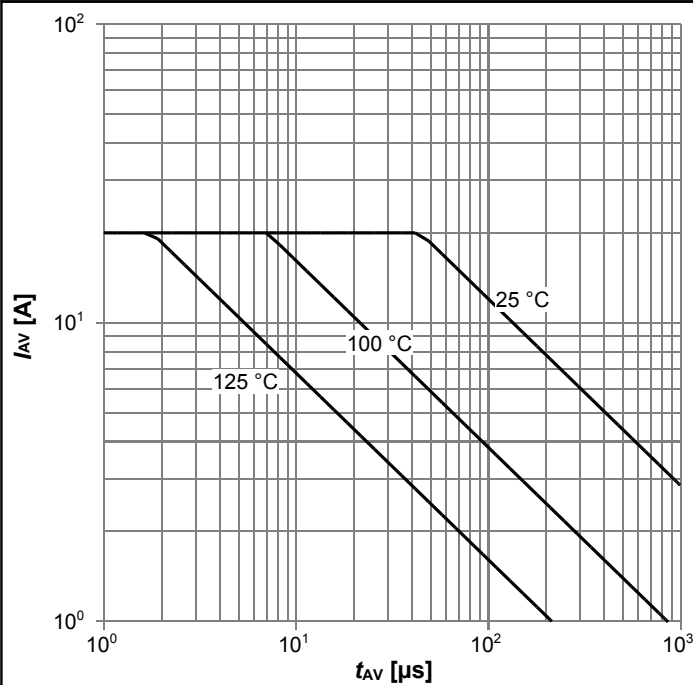

Diagram 12: Forward characteristics of reverse diode



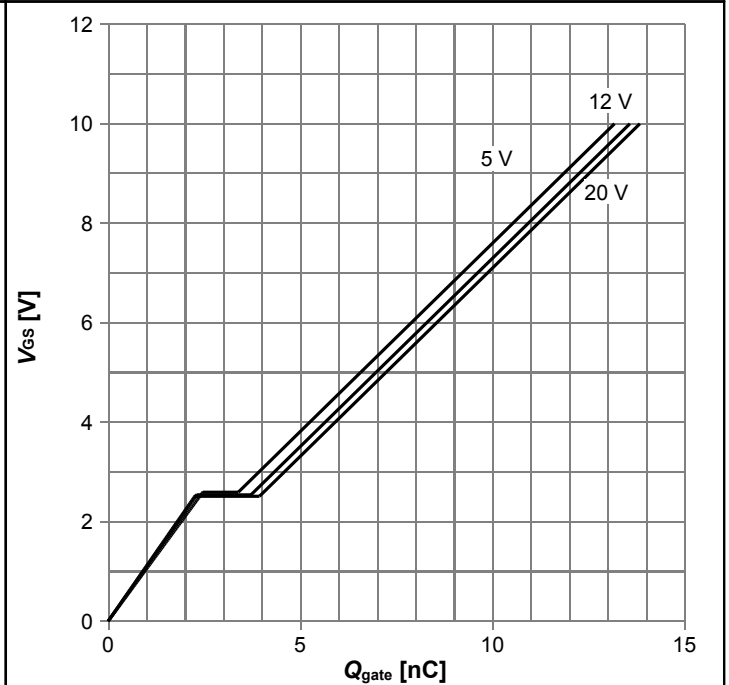

Diagram 13: Avalanche characteristics



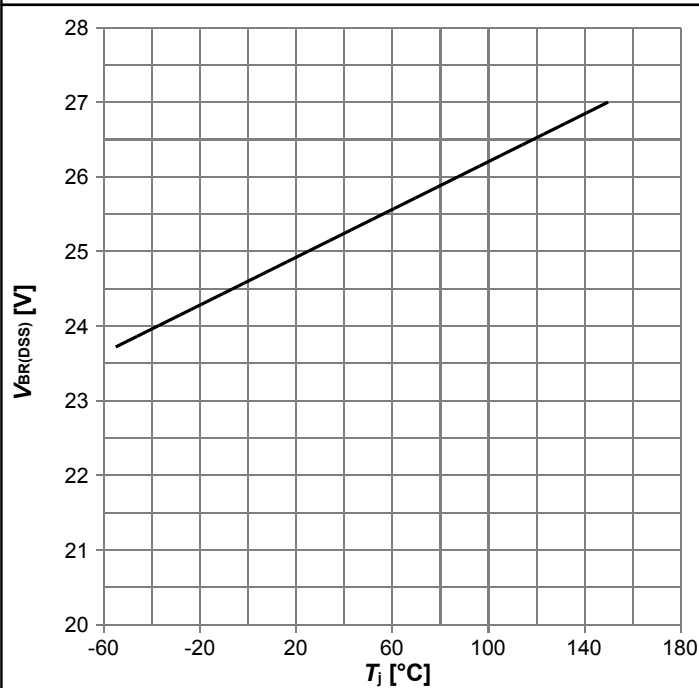

Diagram 14: Typ. gate charge



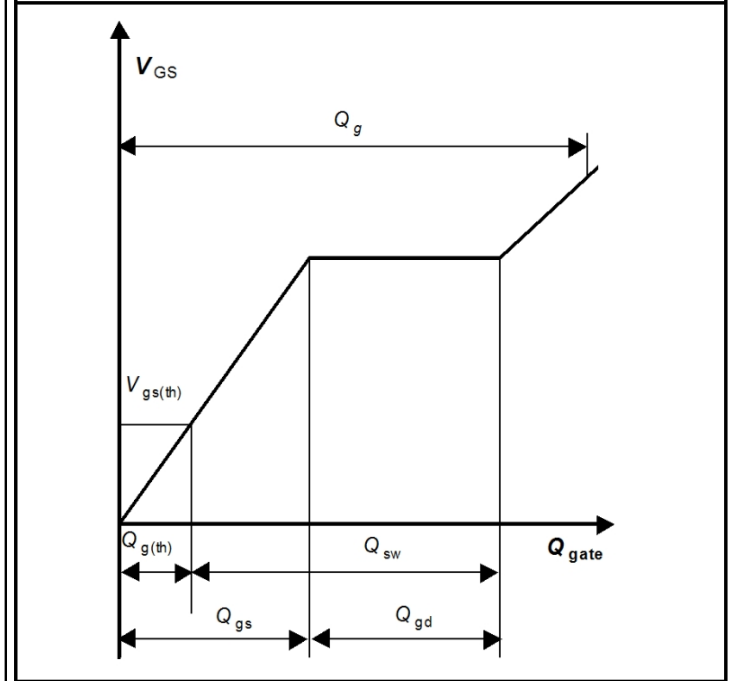
$V_{GS}=f(Q_{gate})$ ;  $I_D=30$  A pulsed; parameter:  $V_{DD}$

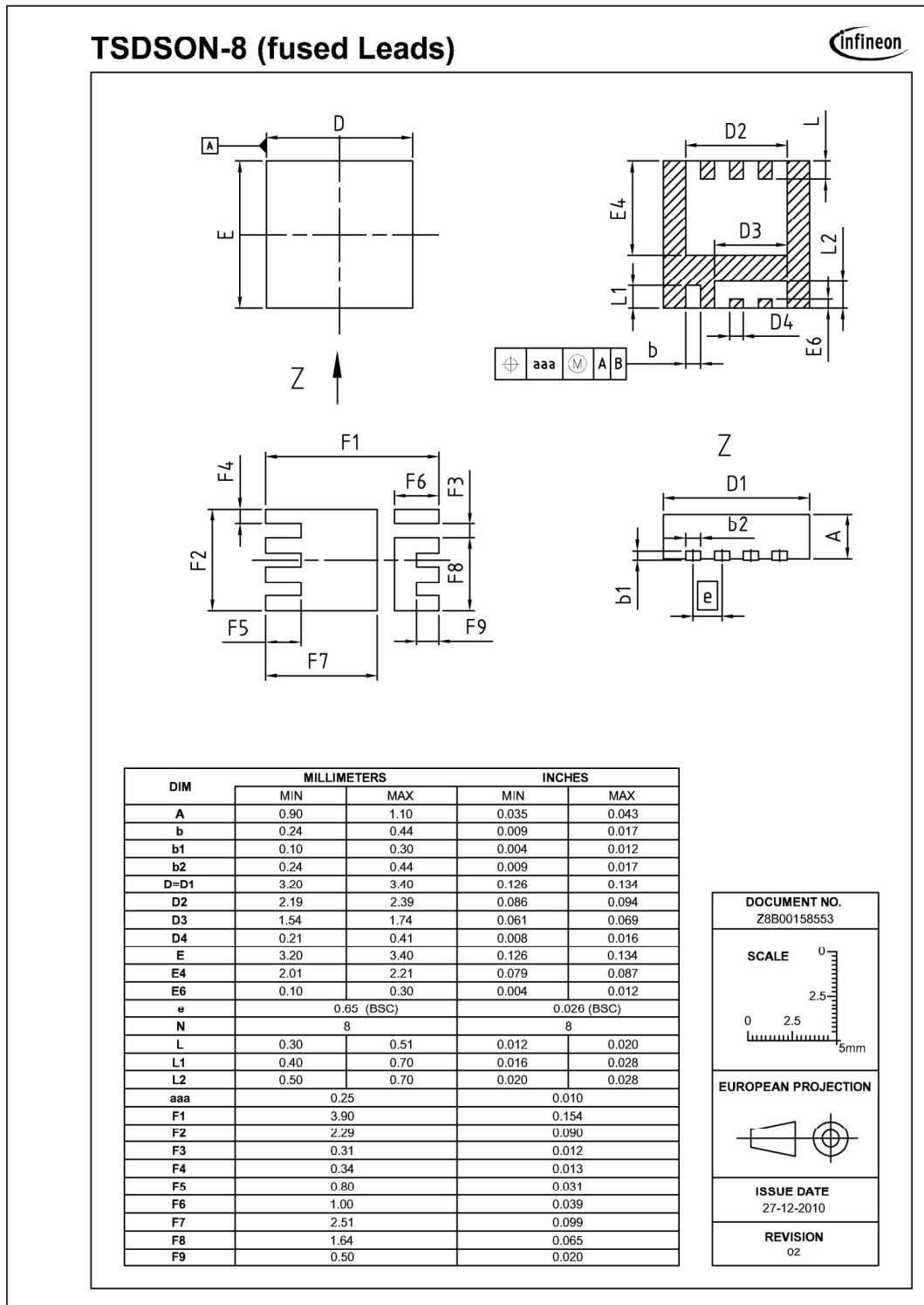


Figure 1 Outline PG-TSDSON-8 FL, dimensions in mm/inches
